The City of Minneapolis has more than 50 volunteer-based boards, commissions and advisory committees that advise the City on issues and help with policy development and administration of services. Boards and commissions fall into a handful of categories: appeal boards, development boards, general advisory boards, and special service districts, which are defined areas within the city where special services are rendered.

Appointments to board and commissions are made twice a year — in the spring and fall. This streamlined appointment process makes it easier for folks to learn about volunteer opportunities, ensure a more open and understandable process for residents and staff, and increase the diversity of the applicant pool.

This was a culmination of a multi-year effort by Logan Park Neighborhood to beautify the most traveled intersection in Northeast Minneapolis. While all of Northeast Minneapolis benefits from this place making effort, LPNA funded it with NRP monies and matching donations collected from neighborhood enthusiasts. The stairwell to the street level on the southeast corner of the overpass was painted and beautified at the same time. #### **Central Avenue Closing**

Beginning in late-May of 2014 and continuing through the November 2014, a construction project will close Central Ave. between 14th and 18th Ave. NE. The Minnesota Department of Transportation (MnDOT) will oversee the removal and reconstruction of the railroad bridge that spans Central Ave. just north of 14th Ave. NE as part of their "Hwy 65 Railroad Bridge Replacement" plan.

Council Member Kevin Reich, City Traffic Department staff and a Metro Transit representative will be at the February 19, 2014 LPNA community meeting at 690 13th Ave NE, Logan Park Community Center from 7-9 PM. This project will have a significant effect on Logan Park businesses and residents, as all pedestrian, bicycle, and vehicle traffic on this portion of Central Ave. is rerouted around the construction area. Recent plans have Metro Transit's Central Ave. bus routes detoured onto Monroe St. NE between Lowry and Broadway, increasing the volume of traffic on one of our neighborhood's busiest streets. LPNA will engage MNDOT, Metro Transit, and the City of Minneapolis to ensure that Logan Park residents are informed the project's progress and that our input is considered when creating closure and reroute plans.



#### **Cistern Project**

Wander by 1828 Jefferson St NE and picture a water cistern on the north wall next to the loading dock. (See diagram below.) Imagine that such an above ground cistern could harvest 66% of the rain fall in one year and irrigate the property all summer in dry spells, all while keeping storm water run-off from polluting the Mississippi. The Mississippi Watershed Management Organizations MWMO has partnered with RED, River east Development, and LPNA to plan this cistern project. The payback on storm water fees and municipal water usage is about 20 years. Benefit to the river, immeasurable.

Winter might not be an ideal time to start thinking about backyard gardening, but it's a great time to get a jump start on gardening and water conservation efforts by setting up a compost bin or rain barrel at your home.

This spring, the Recycling Association of Minnesota is working with cities and counties throughout Minnesota to bring residents affordable rain barrels and compost bins to Minnesota residents. There are many economic and environmental benefits to using rain barrels and compost bins, a few are:

• When you use a rain barrel, you will conserve water by using the rain water rather than from the spigot (which you pay for). It can also help with storm water management on your property in conjunction with your neighbor! It can also reduce storm water runoff, which can be a major pollution contributor to waterways.

 $\cdot$  By using a compost bin you can reduce more than 25% of your waste from going to a landfill which saves you money!
