### City Considers Legalizing Mother-in-law Apartments



The City of Minneapolis is undertaking a review of ADUs, accessory dwelling units, otherwise called mother-in-law apartments, with the aim of making these types of units legal in the City. Town hall type open house meetings are being held in all four quadrants of the City. The Northeast meeting was held August 27, 2014 at Eastside Neighborhood Services. CPED, Community Planning and Economic Development, personnel were on hand to explain the concept of ADUs and to ask for citizen input. Here are the basic facts gleaned from the meeting: 1) the ADUs cannot be larger than the primary unit, 2) the primary and ADU would have to be owned by one property owner, 3) the ADU could be detached from or attached to the primary unit, 4) the ADU could be one or two stories, 5) garages or carriage houses could be converted into an ADU, 6) minimum square footage is 200 sq. ft. 7) It is anticipated that the primary unit will be homesteaded, 8) one aim is to allow multi-generational families to co-habit on a single lot, 9) rental licensing and regulation of ADUs will bring existing undocumented

units into code compliance.

Here are some unanswered questions:

1) what is the number of off street parking spaces required for ADUs? (Currently one off street space is required per dwelling unit.), 2) what access is necessary for fire suppression in adjoined ADUs? Detached ADUs? 3) Should utility billing for ADUs be separate from the primary unit? 4) Should there be an ADU height requirement? 5) What should be the maximum ADU square footage? 6) Should there be a minimum number of bedrooms? 7) Should there be a limit to how many people can reside in an ADU? (Currently, there is no limit on the number of relatives who may live together in a legal domicile.), 8) Will rental licensing and regulation be different for relatives renting from one another as compared to nonrelatives?

Citizens are encouraged to take the survey on line, ask questions, and give input on the formation of this new type of rental housing being considered by the City of Minneapolis.

### Funds Available for Northeast Residents Affected by Flooding

Northeasters struggling with flood damage may be eligible for state loans up to \$70,000.00. Funds for capital improvements that return a home to pre-flooding or comparable condition are available by way of application through the Center for Energy and Environment (CEE).

### **Update on the 807 Broadway Development**

The sale of the 807 Broadway property closed Monday September 8th. Minneapolis Public Schools and Hillcrest Development are very close to a final agreement. Part of the deal's delay has been due to a right-of-way issue on Quincy Street. Minneapolis Public Works will provide their recommendation on the right-of-way issue to the city's Planning Commission on September 15<sup>th</sup>. If approved, the Zoning and Planning Committee would then consider the situation before the City Council would approve or deny plan in October.

### Minnesota Comprehensive Assessment (MCA) Tests Released for Minneapolis Public Schools

The most recent results from our school-system's standardized educational tests – known as the Minnesota Comprehensive Assessment (MCA) – were released this summer and the superintendent of the Minneapolis Public Schools was pleased about what she saw.

Positive trends for almost all student sub-groups in reading, math and science were noted by Superintendent Johnson, and she specifically recognized the district's gains in both reading and math for grades five and eight – these results significantly outpaced those statewide. Johnson stated that districtwide math and science results increased one percent overall, while reading results remained steady.

Johnson did note the importance of replicating successful school -specific educational practices across the district. However, she did not discuss in this press release any additional specifics about the district's plan to address the growing achievement gap between students of color, and those from difficult socioeconomic backgrounds. Past MCA reports have shown that students attending Edison, Sheridan, and Pillsbury schools – schools most associated with Logan Park residents – are among the district's most challenged.

#### Logan Loans

Logan Park homeowners are eligible for three types of loans: Forgivable, Low-interest and Emergency Repair. The forgivable loan is a no interest loan. If you live in your home for 10 years, after the loan is granted, you won't have to pay it back. The forgivable and low-interest loans have no income limits. The low interest loan is set at 4%. Interest income accrued from these loans becomes Logan Park Neighborhood funds for neighborhood projects. The emergency loan is for low income homeowners who need to make a repair right away to keep their home habitable. Fixes vary but must be an emergency.
