## **Business Beat: Central Ave NE and** 14th Ave NE BSNF Rail Road Bridge **Overpass**

There have been many rumors and much emotionally charged discourse regarding the closure of Central Ave NE, otherwise known as State Hwy 65, over the past few months.

The main street of Northeast Minneapolis, Central Ave NE, may be closed for 4 to 8 months beginning in August 2013. Businesses, residents and our state representative, Diane Loeffler are advocating for less disruption.

There were as of December 19, 2012 three options still being reviewed by MN DOT. 1) Close Central Ave and re-route the 16,600 cars, trucks and buses that run under the overpass each day. 2) Keep one lane open each way and restrict some traffic for the duration. 3) Re-route the 8-10 daily trains for approximately six weeks and limit the road closure to that time frame.

History 1: Closing Central Ave NE was the plan that was revealed July 25 2012 and has not been ruled out as of the writing of this newsletter. The meeting was held in the middle of the afternoon at the Northeast Public Library. Not even the State Representative for this area, Diane Loeffler, knew that MN DOT was advocating closure of Central until that day. Original closure date was March 2013 for six months. Ten people attended that July meeting. No neighborhood groups or affected area businesses or residents were invited to the meeting. We don't know who MN DOT invited.

History 2: At LPNA request MN DOT supervisor for the Western Twin Cities District, engineer Scott Pederson, attended the September 14 2012 Logan Park Community meeting at 7 PM. Because MNDOT did not verify until September 10, 2012 that a representative could attend there was no way to get the word out in time to alert the community. In spite of this lack of notice, fourteen community members and 3 business owners shared concerns about the Central closure. Especially problematic would be the re-routing of Metro transit buses to Johnson St NE and University Ave NE from Broadway St

NE to Lowry Ave NE. MN DOT did not know that Pacific and BSNF. Scott Peterson was asked if the bridge was dangerous at the September 14, 2012 meeting and he said no it wasn't dangerous or about to collapse. Rather, the reason for the new bridge was because MN DOT has the money to do it and in some year in the future it would need to be replaced anyway (paraphrased comments).

History 3: October 3, 2012 a meeting of businesses was held on Central Ave at Diamonds. Three businesses showed up because there was no notice given to other businesses. LPNA was not notified as agreed at the September 14, 2012 meeting. At this meeting MN DOT coordinator Ron Rauchle agreed to keep business owners and residents in the loop regarding developments.

History 4: After no communication from MN DOT about the impending probable closure of Central, Lucy Bacon at Diamonds, organized a public meeting on December 19 2012 at her business. It is the first of many meetings scheduled for the new year. Over 20 people in attendance. Diane Loeffler attended and explained the options that MN DOT is exploring. Every business and resident attending agreed that keeping at least one lane open on Central Ave for the duration of the work was necessary for economic viability and personal transit needs.

Many residents rely on the bus for all transit. Walking to Johnson St NE or University Ave NE or to Lowry or to Broadway is not an option for most of these people. People chose to live by transit and this is especially true for our seniors and disabled at 1815 Central Ave NE and transitional housing at 1828 Central Ave NE.

Re-routing the trains doesn't appear to be an option due to the competition factor between Canadian
