

# A Small Area Plan – A Compass for the Future

A Small Area Plan is a way **to set a direction** for the next 5 to 20 years. The ultimate goal is adoption of the plan by the City Council as the defining guideline for future development.

# BACKGROUND

Logan Park Neighborhood has experienced major changes in recent years and will most likely experience continued development pressure given its popular location in the current phase of city growth. A Small Area Plan is a way for the stakeholders (residents, business owners, workers, artists, churches) to have a voice in the planning and structuring of future development of this community they helped build.

**Logan Park Neighborhood Association** is working with The Cunningham Group and the Minneapolis Department of Community Planning and Economic Development to facilitate this planning process. **LPNA represents people who live, own and work within Logan Park Neighborhood.** 

### HOW THE CITY DEFINES SMALL AREA PLANS\*:

"A small area plan is a plan that is developed for a clearly delineated area and gives more detailed recommendations than would be provided in the city-wide comprehensive plan....It builds on the goals, policies and implementation steps in the comprehensive plan to provide a finer level of detail... A small area plan is a document that outlines a long-range vision of typically 15 to 20 years for land use and development in that area. The plan examines the current conditions of the area, develops a future vision of what residents and business representatives want the neighborhood or area to become and then formulates specific goals, objectives, and policies or projects to implement that vision. - Future of Arts District and "Brew District"
- Consideration of possible Conservation District
