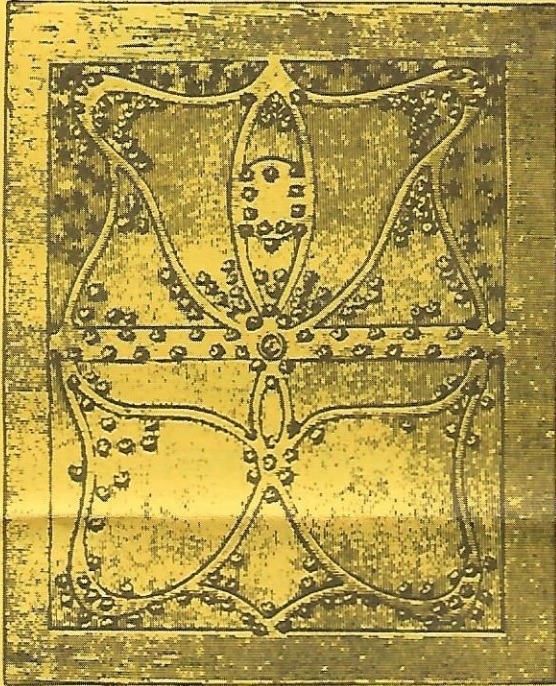

Considering a home improvement project? Minneapolis Inspections as some good news!

Most home improvement projects require a City Inspections Division permit. Here are a few updates for folks who may need a permit in the coming months.

Reduced Rate Parking Coming Soon

Starting in early June, reduced rate parking will be available in the rear of the Public Service Center at 250 South Fourth Street for customers of the Inspections Permit and Development Review counters, located on the third floor. Customers will enter the lot on Third Street and receive up to two hours parking for only \$3.00. Customers must obtain a validated parking token from Inspection Permit staff in order to receive the special rate. Non-validated parking will cost \$15.00. Entrance to the building from the parking lot is on Third Avenue.

Monday Night is Homeowner's Night

Homeowner's Night is back for a fourth year. Every Monday from 4:30 p.m. to 7:00 p.m., the Inspections Permit and Development Review counters will be open exclusively to Minneapolis homeowners. This highly successful program provides a relaxed and low-

key environment for homeowners to review home improvement projects with staff from Inspections Plan Review, Zoning and Planning. If required, customers will also be able to obtain necessary permits for their projects. Appointments are strongly encouraged. Call 673-DECK (3325) for more information or to schedule an appointment.

In addition, the Inspections Permit and Development Review counters are adding at least one staff member from the Business Licensing Division to better serve its business customers. The added staff will ensure that customers with business licensing needs have additional information for their development projects.

These improvements represent the first step toward the City of Minneapolis' long-term plan to bring a "one stop shop" to its customers. In the meantime, the city's goal is to continue to develop fast, easy and customer-friendly initiatives for its citizens and customers. 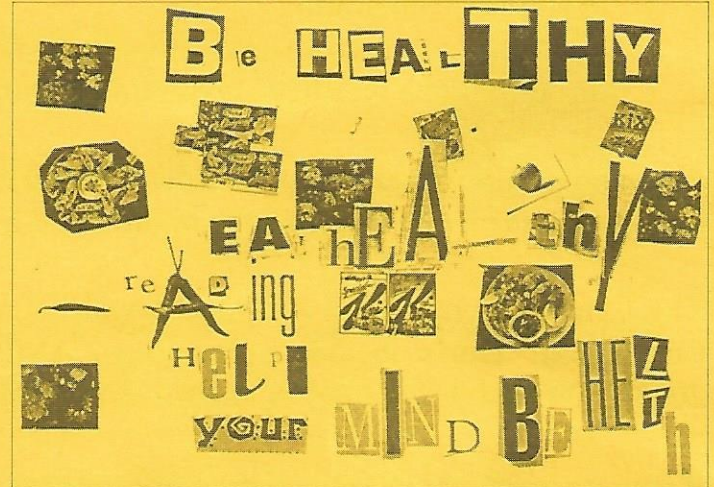

Vermiculite Investigation

MN Department of Health staff involved in the Northeast Minneapolis Community Vermiculite Investigation (NMCVI) will hold an open house for current and former residents of Northeast Minneapolis from 5:00 to 9:00 pm, June 17, at the Logan Park Community Center gym at 690 13th Avenue NE. The purpose of the open house is to answer questions and provide information on the study, which identified ways in which people who lived near the Western Mineral Products plant in NE Minneapolis from 1938 to 2001 may have come in contact with vermiculite processing waste contaminated with asbestos from a vermiculite mine in Libby, MT. A formal presentation will be given at 7:00 pm, but health department staff will be available to answer questions for the entire time.

There will also be displays with information on the study, the plant site, and residential clean up, means of exposure, asbestos-related diseases and vermiculite insulation. For more information, contact Tannie Eshenaur at the Minnesota Dpartment of Health, (651) 215-0916.
