MPRB Comprehensive Plan: Parks for All

The Minneapolis Park and Recreation Board has launched its own comprehensive planning process. Parks for All, the Minneapolis Park and Recreation Board Comprehensive Plan, will be taking place through 2020 to set the priorities and policy direction for the next decade of Minneapolis Parks. This planning process will involve community, MPRB staff and commissioners in shaping the future direction of Minneapolis' park and recreation system. This planning process is separate from the City of Minneapolis' 2040 Comprehensive Plan. It will also build off of the recent MPRB service areas master plans and other existing policies and plans.



MPRB is committed to gathering input and congregating the many stakeholders that make up our beloved park system. The multiplicity of voices and the dreams and priorities shared through this process will help us create and adopt a new comprehensive plan at the end of the year 2020.



Vision Zero Initiative Update & Public Comment Period

The City of Minneapolis has released a draft of the Minneapolis Vision Zero Action Plan, which outlines key steps for the next three years to advance the City's goal of ending traffic deaths and injuries on City streets by 2027.







A final Vision Zero Action Plan will be brought to the City Council for approval by early 2020 after incorporating any changes based on public feedback. The Vision Zero Action Plan is being coordinated with the Minneapolis Transportation Action Plan, a 10-year action plan to guide future planning, design and implementation of transportation projects for all people in all the ways they move around. A draft of the Transportation Action Plan will be released in early 2020.

Fall Street Sweep

Minneapolis Public Works will begin the big task of curb-to-curb sweeping and leaf collection on streets throughout the city on Tuesday, Oct. 22. During the four weeks of the comprehensive fall street sweep, crews will clean about 1,000 miles of city streets. To make sure crews can do the best job possible, temporary "No Parking" signs will be posted at least 24 hours in advance so streets will be clear of cars when they're swept. The first signs will be posted Monday, Oct. 21, and sweeping will begin the next day. Anyone who parks on the street will need to follow posted parking rules or their cars may be ticketed and towed.

Here are just some of the ways to stay informed of the parking rules:

- "No Parking" signs City crews will post "No Parking" signs at least 24 hours before sweeping any streets. Parking will be banned from 7 a.m. to 4:30 p.m. on the day a street is swept. Once the "No Parking" signs are removed, people can resume parking.
- Social media The City will use Facebook and Twitter to post periodic street sweeping updates and information.
- **Phone calls to residents** In addition to the "No Parking" signs that will be posted the day before sweepers come through, the City will make about 3,000 automated phone calls each evening to let residents know their street will be swept the next day.
- Interactive web feature Folks can use a feature on the City's website to find out when the sweepers are coming through their neighborhoods. The Street Sweeping Schedule Lookup will be available at www.minneapolismn.gov/streetsweeping once we get closer to the start date. The fall street sweep takes four weeks, and visitors to the website will be able to find out which week their street is scheduled to be swept. Then, on the weekend before each of the four weeks, the schedule for the upcoming week will be broken down to show which day of the week streets are scheduled to be swept.


