# **Prepare + Prosper Tax Services**

70% of households in the U.S. are constrained by income, have limited savings, and/or are challenged by debt (according to Pew). What's more, about 1 in 4 households in the U.S. are excluded from the financial mainstream. This amounts to more than 194,432 households in the Twin Cities and when you break it down by race, the disparities are stark—1 in 7 white households compared to 1 in 2 black and Latino households (according to the FDIC).

What does this mean? Many people have unpredictable income and are unprepared to weather a financial shock. Many have no checking or savings accounts, are paying high fees for tax preparation, and have no access to affordable credit or loans.

That translates into exorbitant fees and interest rates—hundreds of dollars for a simple tax return, 24% APR on a retail credit card, and 273% APR on a payday loan.

Prepare + Prosper, a nonprofit organization, works to build financial health and provide access to quality tax and financial services, and so much more. They strive to work with people, communities, and systems to break down barriers and develop solutions to real financial opportunity and success.

# **Living Well with Chronic Conditions**

#### Low Income Energy Assistance Program (EAP) Information

If you are having troubles paying your energy bills, apply for Minnesota's Energy Assistance Program that offers eligible residents help to pay their energy bills so they do not have to choose between life's necessities.

The Energy Assistance Program:

- Serves both renters and homeowners.
- Provides benefits to pay for home heating ranging from \$200 to \$1,400, with an average benefit of about \$500.
- Benefit amounts are based on the household's heating costs, household size, and income.
- Provides help with energy disconnections, no/low fuel in the tank, and homeowners' furnace repairs.
- Eligibility is based on the household's past 3 months of income and assets are not counted.

#### **Northeast Emergency Food Growers Network**

The Audubon Neighborhood Association has initiated the Northeast Emergency Food Growers Network to immediately begin preparing, growing, then harvesting, collecting and finally distributing produce that is grown by residents in the Northeast community. Gardeners select two or three varieties of produce, agree to set aside a small section of their gardens specifically dedicated for the Northeast Emergency Food Growers Network. They also agree to use organic methods for growing.

When produce is ready for harvest, a staging area will be set up for easy collection and distribution. Distribution will be handled in one of three ways: 1) through a weekly pay-what-you-can market, 2) directly to the Eastside Senior Food Shelf and other local non-profit food shelves and kitchens, and 3) through Second Harvest Heartland.

#### Saving energy can make your home more comfortable

It takes a lot of energy to keep our homes comfortable during Minneapolis's famously chilly winters. However, homes that look similar may need very different amounts of energy to maintain this comfort. That difference is measurable — it represents the energy efficiency of a home.

For almost a year, the City has been assessing the energy use of houses on the market and has compiled thousands of home efficiency scores. Because many Minneapolis homes are older, the average city score is 70 out of 100. (You can view the publicly available map of scores at mncee.org/tish/yourscore.)

Curious about how you can stay more comfortable by saving energy? Contact an Energy Advisor from the local nonprofit Center for Energy and Environment. Energy Advisors are a free, no-pressure service to help answer home energy questions, identify available rebates and financing, and provide connections to quality contractors.

Improving a home's energy efficiency has multiple benefits:

- improved year-round comfort;
- better indoor air quality;
- lower energy bills; and
- reduced environmental impact.

#### **Emerge Second Chance Community Solar Garden: Subscribers Wanted!**

Did you know you have an opportunity right in Ward 1 to use renewable solar energy, save on your electric bill, reduce pollution and promote local green jobs? The Second Chance Community Solar Garden is installed on the Emerge Second Chance Recycling facility at 1179 15th Ave SE in Minneapolis and they are signing up subscribers now for a projected early summer launch!

Community solar gardens (CSG) are solar arrays on a larger roof (in this case, Emerge) whose electricity is shared by more than one property. CSGs are an opportunity for Minneapolis neighbors to participate in the solar energy revolution, regardless of income, credit score or whether you rent or own, and get a credit on their electric bill. And there are options to participate with no upfront money. The only requirement is that you pay your own Xcel electric bill and not a landlord or third party.

#### BENEFITS of Community Solar Gardens:

- Enables renters or those with roofs unsuitable for solar to use renewable energy and get a credit on your electric bill.
- Enables participation regardless of income or credit score, with a Pay-As-You-Go option that does not require upfront money.
- Energy bill credits move with you, even if you move homes.
- Make your money back (& then some...) with an estimated 8 year Return on Investment (ROI) with the Pay Up Front Option.
- Subscriptions can cover up to 120% of your annual electricity usage.

Electricity rates are locked in for 25 years. Quality assurances, turn-key maintenance and energy guarantees.
